

For Attorneys: Arizona rules protect your client from unfair billing and cost shifting. Cost shifting occurs when an Arizona Certified Reporter works under an arrangement that gives one party discounted rates and makes up lost profit by charging other parties more. ACJA 7-206(J)(3)(b) allows you access to all parties' itemized invoices. ACJA 7-206(J)(3)(d) states the price charged for the **original and one copy plus per diem (items circled red)** must be at least 60% more than what is charged for the **copy (item circled blue)**.

For Arizona CRs: Remember, the individual license holder is held accountable under ACJA 7-206, not the firm. Make sure you have the ability to monitor the production and billing of your work product. When the Arizona licensing authority or an attorney calls, be ready with proof of compliance.

For instance, are you paying extraordinary fees for a word index, shipping from distant locations or even products you did not order? ACJA 7-206(J)(3)(b) allows you access to an itemization of charges for all products and services. Make sure you're billed fairly; insist on an **itemized invoice (circled red)**.

For Arizona CRs: Remember, the individual license holder is held accountable under ACJA 7-206, not the firm. Make sure you have the ability to monitor the production and billing of your work product. When the Arizona licensing authority or an attorney calls, be ready with proof of compliance.
